

# TWS Operation of Lift Trucks

### Attention Managers - Health & Safety Supervisors

WorkSafeBC legislation requires all mobile equipment employees to receive adequate instruction in the safe operation of equipment specific to their workplace. This instruction includes both classroom and hands-on training.

Lift truck operator training must meet the requirements of the Canadian Standard Association, *B335-15*, "*Industrial Lift Truck Operator Training*." Under clause 6.21.3, the lift truck operator's practical performance must be assessed at least 18-month intervals by their supervisor/ employer. Re-training may be necessary if the supervisor determines there are shortcomings in the operator's performance.

WorkSafe BC requires employers and supervisors to be responsible for ensuring all workers are:

- Adequately trained and certified
- Provide direct supervision and correct unsafe acts/conditions
- Ensure only authorized, adequately trained workers operate equipment
- Maintain health and safety standards

### Intended Audience - Course Overview

This course is intended for employees operating forklift/lift trucks in the workplace.
