1. You are a holder of a current Propane fuel handling certificate recognized by *Technical Safety BC Directive D-GA-2017-01* and *CSA Propane Storage and Handling Code CSA B149.2-15-5.2.1*
2. Successful completion of the TWS *Train-the-Evaluator* Program.
3. You possess sufficient industry experience and carry Comprehensive General Liability insurance coverage of at least \$2 million.
Certificate of Insurance for General Liability to be submitted
4. You commit to maintaining the highest training competency standards through the *LPG Industry Code of Practice Policy*.

Frequently Asked Questions FAQs

1. Who is this program suited for?

A Propane Evaluator is typically the owner or manager of a retail operation who sells propane to the consumer. (Retail operators are ultimately responsible for all their workers' training, supervision, and direction).

2. How often must an employee be retrained in the handling of propane?

The LPG industry and TeamWorks Solutions' position requires all persons handling LPG to retrain at intervals not exceeding 3 years. Retraining shall meet the requirements of *CSA Code B149.2-5.2.1 and TSBC Directive D-GA2017- 01*, ensuring knowledge verification and practical skills evaluation for LPG fuel handling.

3. How do I maintain my evaluator qualification?

You must instruct and examine at least one person annually to maintain your evaluator qualification status.

4. Who am I allowed to evaluate?

Only those individuals who are directly employed within your company.
