Workplace Hazardous Materials Information System

Attention Managers - Health & Safety Supervisors

WorkSafeBC's OHS Regulation *Part 5.3: WHMIS* requires the employer to establish and maintain an effective WHMIS program where hazardous products and materials are used in the workplace. The program must include worker education and training which covers the elements of the WHMIS program, major hazards in the workplace, rights and responsibilities, and content required on labels and Safety Data Sheets. This course has been updated to reflect the 2015 standards for incorporating the Globally Harmonized System (GHS) in Canada.

WorkSafe BC requires employers and supervisors are responsible for ensuring all workers are:

- Adequately trained and certified
- Provide direct supervision and correct unsafe acts/conditions
- Ensure only authorized, adequately trained workers operate equipment
- Maintain health and safety standards
